 1. **Oceanside Transit Center Redevelopment***

On September 15, the Chairman and two Committee members attended NCTD's "Open House" on the Oceanside Transit Center Redevelopment Project. Several concerns with the proposal from active transportation and public transit perspectives were identified in the materials displayed and discussed at the Open House. The attached DRAFT letter to NCTD identifies these concerns and provides a number of recommendations. The Committee will review the draft letter and provide input for finalizing it and sending to NCTD and the City Council.
 2. **City Project Review for Active Transportation**

Last year, the Committee requested that City Planning staff develop and implement a Policy calling for Active Transportation review of all significant projects coming before the City. It has also become apparent that such reviews also need to apply to changes in business licensing at existing locations. This item is a follow-up to revisit that issue. City Planning staff has been requested to attend. The Committee may vote to forward a letter to the City Council and City Manager on this issue.

No.	Project/Program	Status Updates
1	BikeShare Programs: -Coastal cities' joint BikeShare programs -SANDAG's guidelines development -Oceanside's ordinance	08/22/22 - Tim Pirkey of Encinitas Bcycle attended meeting and provided background on that program. Howard stated the Encinitas program is an excellent one to model Oceanside's program on.
2	Bike Storage Facility grant implementation.	9/13/21 - Complete - 21 people have applied for membership to date.
3	Loma Alta Creek bridge preliminary design and environmental.	3/14/22 - Caltrans Cycle 6 construction grant to be submitted by June 15 deadline. 6/13/22 - As of June meeting, Final Design had not yet been awarded. Meanwhile, construction costs are skyrocketing.
4	Mainstreet Downtown Shuttle Demonstration Project	8/22/22 - NEV "G'Osider" program has been funded through the fall and is running 10:00A - 10:00P. Free to riders, who use App or flag down vehicle. Ridership has been excellent.

On-Going Projects/Programs/Discussion Items

5	Oceanside's Climate Action Plan (CAP) and its Transportation Demand Management (TDM) Ordinance and Plans	11/8/21 - Planning staff reported that they recently hired additional staff and are tackling some of the implementation steps. Staff also advised there will be an update to the CAP in the next year or so and the Committee can provide input on additional active transportation measures.
6	Onward Oceanside Corridor Plan (Part of General Plan Update)	5/3/22 - The Committee submitted a comment letter on the draft Smart and Sustainable Corridors Plan, a part of the General Plan Update.
7	LCI Classes (Cycling in Traffic)	9/13/21 - In-person and on-line classes are continuing. A separate E-Bike class is now available from SDCBC, more oriented to kids.
8	Coast Highway Road Diet and Incentive Zone	8/22/22 - California Coastal Commission staff has yet to respond to comments the City provided nearly two months ago. City staff will formally address project status at the next standing meeting with CCC staff, which happens in early October.
9	Kelly Street Bike Bridge	5/3/22 - Based on recent conversations with SANDAG representative on the Comprehensive Multi-Modal Corridor Plan process for North County, cross-I-5 connections for cycling and walking are included in that study effort and should be pursued there.
10	SANDAG's 5 Big Moves and their 2021 Regional Transportation Plan (RTP)	8/22/22 - Brian Lane and Chris Kluth of SANDAG presented a report on the Comprehensive Multi-Modal Corridor Plan for north county. The draft Plan will include recommendations to complete the IRT and CRT segments in Oceanside during the first phase of the Plan (2025 - 2030). Public input on the Plan will be sought in October.
11	SLR River trail ownership and improvement issues	3/15/21 - Dir of Public Works said property not likely to be transferred to the City for a long time. Slurry seal is ok but more permanent fixes may be problematic due to ownership issues. City is potentially liable for lawsuits in event of serious accident.
12	El Corazon Park Trail System	
13	Annual Capital Improvement Program Projects	6/14/21 - As of this date, Bike and Ped budget remains funded at \$170K, to cover Coordinator and other projects/matches
14	Coastal Rail Trail Segment between Morse and Eaton	5/3/22 - Caltrans Grant application to study alignment options was approved for this CRT project, with conditions. Requires more outreach and equity work.
15	Loma Alta Creek bridge and connections final design & construction	8/22/22 - Grant resubmittal was due June 15. Awaiting Caltrans award information.
16	Inland Rail Trail	8/22/22 - Staff to seek a debrief from Caltrans on the third grant denial, and City staff is preparing to resubmit a fourth time.
17	Berkeley Study of problematic intersections on Oceanside Blvd.	5/3/22 - Problematic locations are Crouch, El Camino, and College. Staff to provide an update on implementation of recommendations from the study when available.
