1	-Coastal cities' joint BikeShare programs -Oceanside's ordinance	3/18/24 - It was reported at the March meeting that Bcycle will be leaving Encinitas. Not financially viable to serve Encinitas only.
2	Loma Alta Creek bridge preliminary design and environmental.	3/18/24 - Staff reported they are one month away from completing 65% design. 100% design and environmental clearance is at least one year out. City will seek construction funding grant for the 4th time.
3	NEV (Neighborhood Electric Vehicle) Shuttle in Downtown	3/18/24 - Program is now operating two levels of service - 3 vehicles in fall and winter months, 4 vehicles in spring and summer months. SANDAG funding goes away next year, Visit Oceanside is putting up 25% of the cost.

4	Oceanside's Climate Action Plan (CAP) and its Transportation Demand Management (TDM) Ordinance and Plans	7/24/24 - The Chairman submitted a detailed comment letter on the CAP Update as well as other General Plan Update documents.
5	Onward Oceanside Corridor Plan (Part of General Plan Update)	7/24/24 - The Chairman submitted a detailed comment letter on the CAP Update as well as other General Plan Update documents.
6	LCI Classes (Cycling in Traffic)	9/13/21 - In-person and on-line classes are continuing. A separate E-Bike class is now available from SDCBC, more oriented to kids.
7	Coast Highway Road Diet and Incentive Zone	3/18/24 - Staff reported 60% design level is expected to be completed by mid-April.
8	Kelly Street Bike Bridge	5/3/22 - Based on recent conversations with SANDAG representative on the Comprehensive Multi-Modal Corridor Plan process for North County, cross-I-5 connections for cycling and walking are included in that study effort and should be pursued there.
9	SANDAG's Draft 2025 Regional Transportation Plan (RTP) Concepts	2/26/24 - Draft Concepts for 2025 RTP Update were reviewed by the Committee. The draft i long on highway projects and transit and short on Active Transportation, especially in Oceanside.
10	SLR River trail ownership and improvement issues	2/20/23 - Per recent article in the San Diego U-T, the City and Army Corps have agreed on funding for the SLR channel dredging project. Per quote from the Public Works Director, it could be 10 years before the project is completed. December 2023 - Borings and sub-surface repairs began. April 2024 - Borings and subsurface repairs completed
11	El Corazon Park Trail System	8/19/24 - The Frontwave Arena being constructed as part of the El Corazon Development Plan by Sudberry will create new transportation challenges for access by Active Transportation and Transit. Issue to be discussed by Committee in May, June, and August 2024 meetings.
12	Annual Capital Improvement Program Projects	1/23/23 - As of this date, Bike and Ped budget remains funded at \$175K, to cover Coordinator and other projects/matches
13	Coastal Rail Trail Segment between Morse and Eaton	3/18/24 - Consultants have developed several alignment options for northern and southern portions of the project area and have recommended preferred options for further design efforts.
14	Loma Alta Creek bridge and connections final design & construction	3/20/23 - Howard reported that Caltrans passed over this project in their grant awards, and so did SANDAG with additional discretionary funding they had. 3/18/24 - The City is getting the engineering completed and is preparing to apply for construction grants for the fourth time.
15	Inland Rail Trail - Oceanside segment	9/18/23 - Staff announced that the City was successful on the fourth try for this grant, and there will be almost \$500,000 for this study. 2/26/24 - Staff is working on the RFP to select a consultant for the alignment study.
16	Berkeley Study of problematic intersections on Oceanside Blvd.	5/3/22 - Problematic locations are Crouch, El Camino, and College. Staff to provide an update on implementation of recommendations from the study when available.
17	Oceanside Transit Center Redevelopment Project	 2/27/23 - The Committee submitted a letter on our comments and concerns about the proposed project to the City, NCTD, and SANDAG. Follow-up meetings with SANDAG, City, and NCTD have since been held. 3/18/24 - Project representative attended meeting and presented on the changes made to date including a new, separate, customer service building, bike parking, gateway signage, and transit center identification tower.
